I took the 2014 truck for repairs; a checklist for the trucks were handed out and will be filed monthly; still working on the handicap ramp.

**Mayor James** – Worked on ordinances and resolution with Solicitor Coleman and attended a Pinelands Municipal Council meeting.

Teresa Krout – River Road, Lower Bank – The public access to the water on Henderson Avenue needs to be addressed because it is breaking down.

Mayor James – We are working on it.

Committeeman Gadd – I spoke with Kevin today and we are going to look at it and see what we can do.

Sarah Camillo – River Road – Lower Bank – When are we getting sprayed for gypsy moth?

Mayor James - We don't know the exact date but somewhere around May. Residents will be notified.

Sarah Camillo – I have seen the State Police on Route 542, but not on River Road. Have we heard from the State Police?

Mayor James – Nothing for a month, we will get in touch with them.

Sarah Camillo – I'm very concerned about the litter/trash at the bridge. I have pictures, if you need them.

Committeeman Gadd - I'll advise the Code Enforcement Officer.

John Dunlevy – Route 542 – What about the cell tower?

Mayor James - Nothing has been brought to our attention. The company has to get all permits/paperwork together.

Deputy Mayor Seybold – They will have to get through all departments, Pinelands, wetlands, perc tests.

John Dunlevy – Can't they bring a temporary one in to see if it will work?

Deputy Mayor Seybold – We have a dead area and we really need this.

John Dunlevy – What are the carriers?

Deputy Mayor Seybold – The Company will address the carriers.

John Dunlevy – Where is this going to be located?

Deputy Mayor Seybold – Behind the firehouse and a lease have been signed.

John Dunlevy – Anything going to be done on Route 542 regarding speeding?

Committeeman Gadd – We are working on this consistently.

John Dunlevy – We need dirt and the grass cut to add more parking at the Township Beach.

Deputy Mayor Seybold – Yes, as soon as the weather breaks for the dirt and we will look into the grass being cut to expand the parking.
