Committeeman Gadd – Speed Limit Signs will be moved and the State Police has been patrolling. Moderate traffic on the river and patrols have been scheduled; working on the Senior Center and have been back and forth with Sen. Connor with finalizing the lease; Moving along with pricing for the Senior Center; We have ordered warning signs for Henderson Avenue for the rock cage.

Deputy Mayor Seybold – Public Works – April/May 2022 – Several Events of high winds and heavy rain, checking road's for trees and picking up limbs; gravel Township Landing again; painted concrete pillar orange in front of maintenance yard that was a hazard; waited for County most of the day for a salt delivery, no show; accepted 2 truckloads of salt from County; Trash in creek at Old Church Road, waiting for DEP; gravel Washington/Maxwell Road; Patten Lane & Pine Street & School Bus turn around in Jenkins and picked up roadside trash.

On June 3rd went to the County Recycling Center to get the Recycling Schedules; working with a contractor for the handicap ramp; working with a contractor with getting pricing for a revaluation of the HVAC; Talked with Waterways with regards to a streamline well system; Participated in the Clean Communities.

Mayor James – Have been going through the Code Book for revisions. We need stop signs at the end of the Municipal Building's driveways.

Engineer Dixon – That can happen, but an ordinance will be needed.

Mayor James – The Gyspy Moth was done, but I thought they were a little late in spraying.

Barry Cavileer – River Road, Lower Bank – Thank you for the Gyspy Moth Spraying, we may need spraying next year.

David West – DeBow Lane – I've sent complaints within the past 3 weeks, emails & phone calls, I haven't had any response from anyone.

Deputy Mayor Seybold – I emailed you, you should check your email.

David West – We need to have communication.

Mayor James – We will look into it.

Jeanne Bridel – Is there any update on the Mullica Police?

Committeeman Gadd – I haven't heard of anything.

Jeanne Bridel – The Park Police has been at Crowley's Landing.

Committeeman Gadd – When we had a meeting with them, they were going to try, but they are shot handed.

Jeanne Bridel – The light at the turn should be on all the time and change colors.

Mayor James – We would have to call the County.

Sarah Camillo – River Road, Lower Bank – Thanked the State Police for patrolling. We really need patrolling after 11 am on weekends. Where does the ticket money go?

Deputy Township Clerk Bacon – We have a shared service with Bass River and they get the money.

Sarah Camillo – What are you doing with the data that you are complying on the speed limit signs?

Committeeman Gadd – Working with the Engineer on this.

Sarah Camillo - With the repaying of Old Church Road, the speed limit should be addressed.

Committeeman Gadd – We could put a speed limit sign in the middle of that road.

Sarah Camillo – Can we lower the speed limit?

Engineer Dixon – We would have to do a study to lower the speed limits and the Committee could act on it.

Sarah Camillo – The Marine Police was out and it was raining.

Trooper Gonzalez – We have been patrolling; are there any other areas?

Committeeman Gadd – Bot River Road and Route 542.

The audience spoke with Trooper Gonzalez.

Barbara Cavileer – River Road, Lower Bank – We really appreciate what you are doing for us.
