Karen Gfroehrer – We are going to be \$900,000 short for this year's budget. This is due to increase of transportation and schooling for special needs children; plus State Aide has been cut.

Mayor James – When we closed the school, there was a surplus; where is the money?

Karen Gfroehrer – We have used it over the last few years due to transportation and schooling increases. We are looking at a big tax increase of about \$207 per \$100,000. I have been in contact with the County and they are saying to take out a loan, but this certainly won't help. Everything that we are doing is State mandated and it's not funded.

Deputy Mayor Seybold – Public Works – Jan-Feb 2023 – Gravel Smith Lane; Bell Lane & Lance Run Road; Gravel Cedar lane & Ridge Road; Make & Install counter balance for rear of Kubota Loader; CAMCO for salt spreader repair; pressure washed 2014 truck; Loaded up salt & gravel & graded Maintenance yard; several high wind events – checking of roads; snow 2/1/2023 salt roads were needed; picked up roadside trash. – Met with two different heating contractors with regards to the replacement of the boiler, which was installed in 1998 and not effective. I've contacted someone to repair the desks in the meeting room and Tax Collector's office; the shed outback needs a new roof; Ralph Broome wants to set up computers at the Senor Center when we are reading.

Mayor James – The County is here every third Thursday for training also.

Mayor James – Working on ordinances; working on the School Board budget; the proposed cell tower is still in the works.
