Marriage License and Civil Union License

Registrar's Office Hours are: Tuesdays – 2:00 – 6:30 PM and Thursdays 9:00 AM to 2:00 PM

If either applicant is a **resident** of New Jersey, the license **must** be obtained from the Registrar of Vital Statistics in the municipality where either party resides.

If **neither** party is a resident of New Jersey, the license must be obtained from the Registrar of the municipality where the ceremony will be performed and **is only valid** for use in that municipality.

There is a seventy-two (72) hour waiting period before the marriage license can be issued. Both parties and one witness (must be 18 or over) must come into office together to complete marriage license application. Our address is: 2436 Route 563, Green Bank, NJ 08215

On June 22, 2018, Governor Murphy signed Senate Bill No. 427; prohibiting anyone under the age of 18 from marrying or entering into a Civil Union under all circumstances.

A certified birth certificate with parents' names is recommended and a Valid Photo Driver's License is required. If either or both of the applicants have been married or in a civil union before, you need to show proof of how that relationship ended. Examples are a copy of the final decree or a death certificate. Both the applicants **must** provide their Social Security numbers (Married Person Title 37:117).

The license fee is \$28.00, exact cash, money order or check. This fee is Temporarily Waived (P.L. 2022, c.23) from July 1, 2022 through June 30, 2023.
